## Novelis Appoints Jean-Marc Germain To Head North American Business

Kevin Greenawalt will retire on May 31, 2008, following a long and distinguished career in the aluminum industry. Mr. Greenawalt was a member of the senior management team that guided Novelis through its spin-off from Alcan Inc. in 2005 and its eventual acquisition by Hindalco Industries Ltd. in 2007. Prior to the spin-off, he held a series of executive positions with Alcan in both North America and Europe since joining the company in 1983.

Mr. Greenawalt is also a member of the Board of Directors of Logan Aluminum, Inc., and has played a leadership role in the aluminum industry through his association involvement. He has been a Board member of The Aluminum Association since 2004 and has been chairman of its Executive Committee since October 2007. He has also been a director of the National Association of Manufacturers since 2007.

"Kevin has been a great asset to Novelis and to the industry as a whole over his long career," said Brooks. "We will miss his solid leadership and wise counsel, and we wish him well in his retirement."
