NOTIFICATION OF THE REMOVAL FROM LISTING AND REGISTRATION OF THE STATED SECURITIES The New York Stock Exchange hereby notifies the SEC of its intention to remove the entire class of the stated securities from listing and registration on the Exchange at the opening of business on May 29, 2007, pursuant to the provisions of Rule 12d2-2 (a). The merger between Novelis Inc. and AV Metals Inc. a subsidiary of Hindalco Industries Limited became effective before the opening on May 15, 2007. Each share of Common Stock of Novelis Inc. was converted into \$44.93 in cash per share. The Exchange also notifies the Securities and Exchange Commission that as a result of the above indicated conditions this security was suspended from trading on May 15, 2007.
